## **Terms and Conditions of Travel – 2017**

### **Registration / Confirmation**

Registrations can be made by mouth, telephone, in writing or via e-mail. The person making the registration does so in his/her own name as well as in the name of all others included the registration request. The person making the registration is contractually responsible for him/herself as well as the others named in the registration. By making a registration these terms and conditions are accepted.

### **Service Performance and Amendments**

The performance of services is in accordance with the travel description on our website found under (program). However, we reserve the right to make amendments to the services described due to unforeseen changes in circumstances that make amendments necessary. We also reserve the right to make small changes that do not affect the character of the holiday. Depending on the number of participants registered for the holiday (insufficient registrations), we reserve the right to perhaps make one group out of two, to arrange lessons with one instructor or to offer instruction in smaller groups with fewer hours. If a dance instructor becomes unavailable, we will make sure that a suitable replacement is found.

### **Cancellation**

The tango holiday can be cancelled at any time. The holiday is considered cancelled after Sunshine Tango has received and confirmed a written cancellation request per e-mail.

We recommend taking out travel insurance!

The following cancellation fees apply:

up to 60 days prior to travel	50,00 € cancellation fee
up to 45 days prior to travel	50% of the holiday price
up to 20 days prior to travel	80% of the holiday price
less than 20 days prior to travel	90% of the holiday price

### **Booking of Rooms**

If the room booked is not available or if changes are made at short notice, Sunshine Tango reserves the right to offer a similar room of equal standard.

### **Liability**

Each participant is personally responsible for all activities that take place during the tango holiday. Each participant is also personally responsible for travel to and from the holiday location and transfer to and from the airport. Sunshine Tango accepts no liability and recommends that all participants take out holiday insurance (travel cancellation, accident and return travel insurance). Liability of the tour organizer (Sunshine Tango) is limited to twice the amount of the cost of the holiday. Sunshine Tango is a German company and the following liability limitation law applies BGB (§651, Abs.2).

### **Cancellation by the Tour Organizer (Sunshine Tango)**

If a minimum number of participants is not reached, Sunshine Tango may cancel the holiday up to 6 weeks before it is due to begin. In this case all monies paid shall be refunded to the participants without delay.

### **Revocation of the Contract because of Exceptional Circumstances**

Should the Tango Holiday become very difficult, hindered, endangered or impossible because of an unforeseen Act of God, Sunshine Tango and or the holiday participants able to cancel the holiday without having to adhere to a cancellation deadline. In this event, Sunshine Tango cannot accept responsibility for flight tickets or similar that have been paid for. Equally, participants shall not have to pay for the holiday.
